### **3.** Detailed information on the supporting documents proving experience: For public and private sector employees

- Certificate from the relevant insurance institution, from which the duration of the insurance can be obtained and/or
- Legal supporting documents from which the subject of the employment and the type of experience
  or the status of the employee can be obtained (employment contract and/or recruitment, and/or
  employer's certificate with the description of the duties. In the case of an objective inability to

Employees of the public sector can, alternatively, instead of the certificate of the insurance institution,

present a certificate of the relevant public sector institution, from which the duration and the subject of the experience can be deduced. **For other freelancers** 

- Certificate from the relevant insurance institution, stating the duration of the insurance and/or
- Legal supporting documents (contracts and/or invoices for the provision of services and/or start of
  activity and/or employer's certificate or other certificate, from which the duration of insurance for
  the type of experience requested by the call can be obtained.

It is clarified that the evidence of the qualifications of the interested parties should be legible copies of the original documents, in accordance with the provision of article 1 of Law 4250/14 and that the RC may carry out a sample check of them in accordance with paragraph 2b of article 1 of Law 4250/14.

As experience taken into account, it is persumed the employment acquired under an employment contract or under a project lease contract in the public or private sector in tasks or projects, identical or related to those mentioned in this call, as they are mentioned in this call, **after obtaining of the basic degree** with which he participates in the competitive process and under the conditions detailed below.

In case the candidate's experience in research projects or programs is required, this experience is proven with the following supporting documents:

o Certificate of the Scientific Responsible of the project, which will state the research project participated in, the subject of the research and the time of the candidate's participation **and** 

o Certificate from the Head of the Financial and Administrative Support Unit of ELKE or the President of the Research Committee stating the title and duration of the research project or program, the time of the candidate's participation and the contractual relationship the candidate had with the Institution (fixed-term or project work contract).

Experience that may be invoked by the candidate and does not result from the required supporting documents, as defined above, will not be taken into account.

## 4. Evaluation Procedure

- Submitted proposals will be evaluated by a three-member Evaluation Committee based on the requirements/provisions of the call.
- The Evaluation Committee receives the proposals that will have been submitted in the context of this invitation from the Procurement and Tenders Department of ELKE and proceeds with their evaluation.
- The Committee rejects the late submission proposals, as well as the proposals of candidates who do not meet one or more formal qualifications necessary for their participation in this call.
- The Committee evaluates the candidates based on their CVs, undergraduate and postgraduate degrees, grades, knowledge of foreign languages, experience, additional qualifications and other relevant activities, according to the table above and then calls the candidates to an interview (if provided for).
- In the event that the evaluation process provides for an interview and the candidate does not attend the interview, he is rejected and cannot be further evaluated by the Evaluation Committee. Candidates will be notified of the date and time of the interview by sending an e-mail to them, to the e-mail they have indicated as contact details in the proposal they will submit (for this reason, all candidates to state their contact details correctly and legibly). The date and time of the interview is determined by the members of the Evaluation Committee, it is mandatory for the candidates and cannot be changed. It is noted that the interview process can also be done by electronic means.
- The responsibility for conducting the interviews rests with the three-member competent Evaluation Committee appointed by decision of the Research Committee
- The time and place/venue of the interviews will be announced to those interested who meet the

necessary formal qualifications through the website of the Research Committee (<u>http://rc.uowm.gr/</u>).

- Based on the evaluation of the candidates, the Evaluation Committee prepares the evaluation proposal and submits it for approval by the UOWM Research Committee.
- ELKE PDM compiles and publishes in Diaygeia and the website of the Research Committee https://rc.uowm.gr/ the ranking tables of accepted and rejected candidates
- The Candidate who wishes to submit an objection regarding the result (decision of acceptance of results) is entitled by sending an e-mail to the email address <u>rc-proskliseis@uowm.gr</u> within 5 calendar days from the day following the date of posting of the decision of acceptance of results in Diavgeia and on the website of ELKE PDM. The candidate has the obligation to be informed about the posting of the results from the website of the Research Committee rc.uowm.gr as well as from Diavgeia (Organization: University of Western Macedonia, Org. Unit: Special Account for Research Funds, Type: Tables of Winners, Appointees & Runners-up).

## 5. Processing of Personal Data

The Special Account for Research Funds of the University of Western Macedonia will process, as a data controller, the personal data included in the above documents supporting the participation of interested parties in this call and those provided directly by the interested party in the context of any personal interview, with the purpose of examining the submitted proposal by the competent evaluation committee, ranking the results in a relevant table and posting the ranking table on the Internet for reasons of transparency and accountability (DIAYGEIA Program and ELKE website), evaluating any objection by the competent Committee Research and the conclusion of a contract with the appropriate interested party, in accordance with the terms herein. The legal basis for the processing is paragraph 1 point b of article 6 of Regulation (EU) 2016/679 (taking measures before entering into a contract and, in case of conclusion, performance of the contract) and paragraph 1 point e of the same article and Article 5 of Law 4624/2019 (fulfilment of a duty performed in the public interest or in the exercise of public authority) and, for posting the results on the Internet, the legal basis is paragraph 1 point c of Article 6 of the Regulation (EU ) 2016/679 (compliance with legal obligation). The personal data will be transmitted to the relevant funding body (e.g. NSRF, European Union, etc.), to the authorities or services responsible for the management and control of the process and may be transmitted to co-applicants having a superior legal interest in this regard, upon their written request. Without prejudice to more specific provisions or legal claims, the data of rejected candidates will be stored for a period of up to six months from the end of the contracting process. The interested parties have the right to access their data, to correct inaccurate or complete incomplete data, to delete the data if they are no longer necessary in relation to the purposes for which they were collected or otherwise processed or if they object to the processing if there are no compelling reasons and legitimate grounds for processing, and restriction of processing. For any issue related to the processing of personal data, anyone interested can contact the Data Protection Officer, Mr. Dionysios Kalogeras, by contacting the email address dpo@uowm.gr . In the event that the interested party considers that the protection of his / her personal data is affected in any way, he/she can appeal to the Personal Data Protection Authority (www.dpa.gr).

## 6. Right of Access to Documents

During the objection period according to the above, the candidates have the right to access the supporting documents of other candidates, upon their written request and only if their request is absolutely necessary for the legal interest (unsuccessful candidates or candidates which they consider to have been injusticed).

## 7. Other Conditions

From all the proposals submitted according to the above specifications, the one that best meets the project's requirements will be selected and awarded a work contract on the basis of contractual freedom.
 Only proposals / objections that will be received by the set date and time will be considered. ELKE UOWM bears no responsibility for the content of the candidacy files that will be sent.

3. Changes to the proposals (replacements, corrections or submission of additional documents) are not

allowed after the expiration of the deadline. During the process of evaluating the proposals, the Evaluation Committee, respecting the principles of equal treatment and transparency, may ask the candidates to submit, complete or clarify the information of their proposals.

4. Any diplomas of higher education (undergraduate, postgraduate and doctoral) which are included in the Required or Additional Qualification and have been awarded by institutions abroad, must be accompanied by certificates of recognition by the Hellenic National Academic Recognition and Information Center (Hellenic NARIC). In addition, when the call for expression of interest stipulates a grading/points scale of the degree, it is required to submit a certificate of the equivalent degree grade issued by NARIC. In the case that, all certificates for the recognition of a degree are provided but the certificate of the equivalent degree grade by NARIC is not submitted, the candidate's proposal will be accepted but no points for the degree will be awarded.

5. It is pointed out that the procedure for submitting proposals for the conclusion of a project lease contract is not competitive, while the selection of a contractor has the character of accepting the proposal and not "recruitment". The evaluation process will be completed by compiling a ranking list, (No ranking list is required when only one proposal has been submitted or when only one proposal has been graded) while those selected will be notified individually. In case of a tie, the proposal of the interested person is selected in order a) with the longest experience, b) with the highest bachelor's degree mark. c) with the highest postgraduate degree mark.

6. Any submitted proposal that does not meet the Required criteria of the call of the expression of interest will not be examined any further and will be automatically rejected.

7. Throughout the duration of the project, it is possible that the selected candidate(s) may be replaced, if necessary, by other candidate(s) of the present call and in accordance with the ranking list.

8. ELKE UOWM does not undertake any commitment to conclude a contract, as it is left to its full discretion to conclude or not contracts, as well as their number, excluding any claim of the interested parties.

9. The project assignment will take place in accordance with the provisions of the Program Implementation Guide.

10. For candidates, language knowledge shall be certified according to Article 1 of Presidential Decree 146/2007 " Amendment of provisions of Presidential Decree 50/2001 Defining qualifications for the appointments of posts in the public sector" (Government Gazette 185/3.8.2007/Issue A'), in conjunction with the last passage of paragraph 1 of Article 1 of the Presidential Decree 116/2006 "Amendment of Article 28 of Presidential Decree 50/2001" (Government Gazette 115/9.6.2006/Issue A'). For foreign candidates, there shall be equivalent language skills verification.
